The faculty members have served as presidents of national and state level academic bodies. The Department has provided the national leadership in terms of having held conferences such as National Association of Geographers, India (NAGI), Indian Institute of Geographers (IIG), Institute of Indian Geo-morphologists (IGI) and Rajasthan Geographical Association (RGA). Faculty had also availed Academic Fellowship tenable in the UK as Commonwealth fellow during the early 1990s. The Department is presently running M.A./M.Sc. and M. Phil./Ph.D. Courses. Research is pursued in different fields of applied nature such as mapping of land degradation, desertification and crimes, land use and regional planning and resource management especially water resources conservation and aquifer augmentation. Presently more than 200 scholars are engaged in doctoral research work, out of which more than 100 scholars are getting Junior/Senior Research Fellowships awarded by the UGC, CSIR and Rajeev Gandhi Fellowship Scheme. The Department of Geography is well equipped with labs of GIS and Cartography. The Department maintains a Weather Station and it is also facilitated with smart class room.
